Non-Resident Member	For businesses and organisations with no Japanese subsidiaries (except representative office). (In case you establish a Japanese subsidiary, you become a full member.)	70,000 yen
New Member	For businesses and organisations in Japan who have not been a member of the AHK Japan for at least three years. Valid for one calendar year.	
Startup Member	For startups and entrepreneurs in Japan with less than ten employees. The applying entity as well as any controlling entities must have been established within five years including time since participation of investors. (The startup membership is valid for five years after the founding year and will automatically be changed into a full membership from January in the following year.)	50,000 yen
Non-Profit Member	For public bodies and non-profit organisations.
