CHAMBER PRESIDENT'S ADDRESS

MR JENS PAPPERITZ

Annual General Meeting of the Southern African – German Chamber of Commerce and Industry 29 June 2023 10.30h

Dear Mr Berg, Dear Members and Friends,

ast year was again a mixed bag with quite a number of challenges and difficulties. Starting with a few positive developments: The Covid/Corona crisis seems to be behind us and life returned slowly but surely back to what we knew as normal. But what is normal these days? The fact that we are again holding our AGM in a hybrid manner, meaning that some of our members attend virtually and others in person, shows that we are getting used to something we would have hardly imagined 4 years ago. I am convinced that at least part of our business and private environment has changed forever. But – as human beings – we will adapt and hopefully make the best out of it.

A few figures/ numbers that I need to mention in my address:

- The German South African business relations had in 2022 all in all not too bad a year, much improved as compared with 2021.
- The total trade volume came to 24.2 bn Euro. South Africa had, for the fourth time since 2001 a surplus in the trade with Germany of 4.6 bn Euro.
- Exports from SA to Germany came to 14.4 bn Euro (+2.1 bn) while German exports to SA amounted to 9.8 bn Euro (+2.8 bn).
- The German business community remains committed to working closely with our South African partners in creating a better economic and social environment. The Chamber as the representative of German business in South Africa continues to express our opinion regarding certain developments, most recently with a position paper on the Employment Equity Act, which burdens our companies with more administrative duties and is in large parts not practicable.
- Another topic that we addressed with the SA
 Government is the electricity situation. Continuous
 loadshedding has a very negative impact on our
 member companies and is an investment hindrance.
- Lastly, but certainly not least I have to mention the situation in the Department of Home Affairs.
- It is simply not acceptable that normal work permit applications and applications for a critical skills permit take more than 3 months and in case of the latter up to a year.

Despite many challenges, which led to the closure of a company in the water sanitation sector and the return of the Managing owner to Germany, selling his company in SA, I am happy to report that there were also some "newcomers" that we could welcome in SA and support their process of establishment:

But what does that mean in day-to-day terms? Anecdotally, most of our larger and more established members are doing fine, some are even thriving by providing the products and solutions that help mitigating the electricity, water and transport crises.

Despite many challenges, which led to the closure of a company in the water sanitation sector and the return of the Managing owner to Germany, selling his company in SA, I am happy to report that there were also some "newcomers" that we could welcome in SA and support their process of establishment: I will not mention any names but there is a good example in the machinery sector, that closed down just before the Corona crisis and is now in the process of re-establishing itself with a view to the broader Sub-Saharan Market. Another good example is a company in the agricultural sector, producing herbs and spices for the export to Germany as well as the local market. Another positive example is a family-owned company from the chemical sector that is currently planning to enter SA by taking over their JV partner, creating about 300 - 400 new jobs, producing for the local market as well as the export market in Europe.

I do predict that it will be more and more those small companies that can and will create the investment momentum that South Africa so desperately needs – and we as a chamber can play a role in "luring them in"..., i.e., attract interest, inform about the opportunities, help to connect them ...

Chamber Membership:

Our membership remained more or less stable with around 455 fully paid-up members in total. We had to clear our database in 2022. In the first months of 2023, we continue our growth, although slowly with about 4%.

Events:

In 2022, we could start again with events in person. Most of our meetings, seminars, etc., were held as hybrid get-togethers. This new format was extremely well accepted: More than 54 events, directly arranged for by the Chamber attracted around 3,400 participants. Outstanding events last year were:

- The visit of German Chancellor Olaf Scholz on the occasion of the Chambers 70th Anniversary as well as
- Our 70th anniversary celebration, attended by Minister Pravin Gordhan, and
- The absolute highlight, the German African Business Summit in Johannesburg in December 2022. Main guests were German Minister of Economic Affairs and Climate Action, Dr Robert Habeck and South African Minister of Trade and Industry, Ebrahim Patel. African Ministers from six countries joined the Summit.

Representations:

The Chamber represents the Free State of Bavaria (since 2007), the Free State of Thuringia (since 2019) and Baden Wuerttemberg (also since 2019). Delegations from Baden Wuerttemberg, Bavaria and Thuringia were arranged by the Chamber. Main emphasis for these representations are the facilitation of business relations between companies as well as the focus on renewable energies, Hydrogen cooperation and third country cooperation.

Office Mozambique:

Our office in Maputo, Mozambique, continued with the task of bringing Mozambican companies into the supply chain of German companies and worked closely together with our Competence Centre for Mining. Our representative, Mr Holger Hey, left the Chamber in June this year to continue to work for Messe Cologne. We are currently looking, in close cooperation with the German Ministry for Economic Affairs and Climate Action for a new colleague.

Office Zambia:

We have a similar situation in Lusaka, Zambia. Mr Rene Zarske, who rebuilt the office after Corona, left the Chamber and is now working for GIZ, the German International Cooperation, in Lubumbashi. We are currently looking for a suitable candidate. We have spoken to a number of candidates and await a final decision from the Ministry of Economic Affairs and Climate Action regarding the finance.

Competence Centres:

Our Competence Centre for Sustainable Energies, based in our Cape Town office underwent a major repositioning and is since last year our "Competence Centre: Climate and Environment". I reported last year that we merged our CC's: Sustainable Energy, Water Management and Circular Economy/ Waste Management into one(virtual)Competence Centre, headed by Mr Jens Hauser. Staff members are located in CT, Durban and Johannesburg. We employed a new colleague for the Competence Centre which is becoming one of the core centres for the Chamber due to Hydrogen projects in SA and Namibia becoming focus points within the SA – German Energy Cooperation.

The Competence Centre for Mining and Mineral Resources located in our headquarters in Johannesburg, covers almost the entire region of Southern Africa. Projects are implemented in cooperation with our partners from BGR (Federal Institute for Geosciences and Natural Resources), DERA (German Mineral Resources Agency) and especially the Ministry BMWK (Federal Ministry of Economic Affair and Climate Action). These are centred around the commodities needed for the e-mobility like Lithium, etc. Therefore, we work very closely with Mineral Councils all over the region with special emphasis on the Democratic Republic of Congo. Business delegations to and from Congo are organised in close cooperation with the GIZ.

The Working Group Mining, established in 2018, provides a platform for networking and discussions within the mining industry and relevant partner institutions. We want to thank our cooperation partners: the Minerals Council South Africa, ISSA Mining and MIASA (Mining Association of Southern Africa), as well as our partner institutions in Southern Africa, mostly the former "Chamber of Mines", now called "Minerals Council".

The Competence Centre Industry and Trade Fairs had an encouraging year 2022. After the Covid/Corona pandemic had subsided, the trade fairs business picked up very well. Approximately 2000 (exactly 2044) SA business representatives travelled to German Trade Fairs in Germany. Including the National Pavilions, organised by the DTIC, we counted 36 exhibitors with sub exhibitors. We expanded our activity to trade fairs in Asia, e.g. ProWine in Mumbai (India) and the International Sweets fair in Middle East (Dubai). We were asked by the German Trade Fair organisations Messe Duesseldorf and Messe Cologne to support them in these fields.

2023 started very well: 2600 (exactly 2617) trade representatives travelled in the first 5 months to German Trade Fairs and more than 100 (exactly 109) companies from SA exhibited in Germany, e.g. Boot, Euroshop and ProWine.

The "Sourcing Desk" at the Chamber, in which we, in cooperation with GIZ (German International Cooperation) get SA companies in touch with potential German cooperation partners in terms of integration in the German value chain. We consider this to be of great strategic relevance since some of our member companies still have obligations arising from the NIPP. The platform that I mentioned last year will finally be launched in the second half of this year after encountering some technical challenges.

Last year I reported that the Chamber was mandated by the Fed. Ministry for Agriculture, Food Security and Forestry (BML) to establish the "Competence Centre: Agriculture". Main tasks is to offer a point of contact for farming organisations from both countries, facilitate delegations and the direct cooperation between farmers from both countries. Within this Competence Centre, we are glad that the above-mentioned farming company successfully established itself in SA and produces now around 500 tonnes of herbs annually.

Spearheaded by the Skills Expert, funded by the BMWK, the Chamber is preparing to launch two new training initiatives, namely in the agricultural sector (horticultural training) and eco-tourism. We will keep you updated.

Thanks:

I would like to express my gratitude to the Federal German Ministry of Economic Affairs and Climate Action and to the DIHK for their support, organisationally and financially.

A special word of thanks to the German Embassy, to Ambassador Andreas Peschke, Deputy Ambassador and Head of Economic and Global Affairs, Enrico Brandt, and Dirk Berg and their team for the support and great cooperation throughout the year.

I want to thank all members of the Advisory Board and the Directorate for their support in the past year. Thank you also to management (Matthias and Bastian) and staff of the Chamber for their support and dedication. Although it is difficult to single out individuals, I would like to give a big thank you to Nokwanda and her team for an excellent job in organizing our summit in December!

Last but certainly not least: Thank you to all our members and friends for your ongoing interest, your individual and collective contributions and commitment towards the economic development of both Germany and Southern Africa. It is much appreciated.

FINANCIAL REPORT

CHIEF EXECUTIVE OFFICER, MATTHIAS BODDENBERG

hank you for the opportunity to report on the Chamber's financial situation in 2022 and the outlook for 2023. I am happy to report that the financial situation of the Chamber is solid.

FINANCIALS

Revenue

Total revenue in 2022 was 28,100,481 million rand – a considerable increase from 18,243,749 million rand in the previous year. The Chamber's business is slowly returning to normal. Surplus for 2022 was 0,884 million rand; in 2021 we had a surplus of only 16,068 rand. The BMWi/DIHK (Deutscher Industrie- und Handelskammertag) contribution decreased slightly to 10,412 million rand.

Most of the remainder of the Chamber's income is through membership fees and services. Membership fees amounted to 1,823 million rand.

Income from services and delegations increased most, from 14,545 million rand to 23,965 million rand, since we were able to host more delegations from Germany to Southern Africa. Another important contributor was the German-African Business Summit in December last year.

Income from trade fair representation more than tripled, from 249,000 to over 858,000 rand.

Expenses

The bulk of our expenses are personnel related – salaries and wages amount to 15,9 million rand; general office running costs of all five offices (Cape Town, Durban, Lusaka, Johannesburg and Maputo) amounted to 4 million rand and motor vehicle and travel expenses were close to 900,000 rand. Chamber functions and events cost 6,580 million rand, mostly due to the German African Business Summit.

Finally, other expenses/cost of sales amounted to 10,061 million rand, basically unchanged as compared with the previous year. The first five months of 2023 show a similar picture.

2023 revenue (January to June)

Total revenue was 11,379 million rand with services and delegations at almost 6 million rand, clearly pointing to a revival in this sector. Membership fees increased quite considerably to 2,134 million rand, partially due to the increase in membership numbers and the exchange rate. Income from trade fairs for the first five months on 2023 equalled that of the whole of 2022.

2023 expenses (January to June)

Personnel costs came to 6,144 million rand and cost of sales amounted to 3,145 million rand. The total expenses came to 6,670 million rand, leading to a surplus for the first five months of 4,709 million rand.






SURPLUS FOR THE YEAR

POWER AT LAST

Microgrids Bring Sustainable Energy To Remote Villages

Around 1.2 billion people worldwide do not yet have access to electricity. With microgrids, even remote places can be electrified, with renewable energies that are climate-neutral and sustainable.


Upper Blinkwater in South Africa is a model village.

hen Neliswa Gaju wants to know what's going on in the world right now, she goes into the living room and turns on her TV. That may sound trivial, or like a boring, selfevident routine. But it's not. Because Neliswa lives in Upper Blinkwater in the Eastern Cape of South Africa about 200 km north-east of Port Elisabeth. The small village with about 70 households is so remote that it was not connected to the national electricity grid. For a long time, there was no electricity here until 2020, when a small independent power grid - a so-called microgrid - was installed. Many different companies and associations are involved in the project, which was initiated by the Eastern Cape Province in South Africa and the federal state of Lower Saxony in Germany.

"EVERYTHING IS EASY NOW"

"Our life was very, very difficult at that time of our parents, the old time," says Gaju. "At that time, we were using fire for cooking, even for making warm water. Every morning, staying up early in the morning and doing that job. And cooking, everything we were doing on the fire. Even lighting, we were using candles and paraffin to light at night. Now, everything has changed. Everything is easy. We can use electricity for cooking, ironing, fridge, washing machines. We have electric lights and TVs. We can watch everything, even from overseas."





THE PLANT

The microgrid in Upper Blinkwater consists of three main components: a photovoltaic system (75 KWp), a diesel generator and a battery storage system. "The smart grid is connected and controlled by components from Siemens," explains Desmond Mabilo from Siemens Smart Infrastructure, who accompanied the installation of the system. "A SICAM Microgrid Controller controls the energy sources (PV, diesel generator, battery) and a load-shedding module ensures that the electricity is used optimally. With this system we ensure that there is at least enough energy for each household to run a mobile phone charger, a TV plus satellite dish and a kettle. In addition, there are some communal washing machines and a few commercial machines."

A SUSTAINABLE SOLUTION

"The diesel generator, which of course is not sustainable, is only used when the solar system cannot run and the battery storage is empty," says Mabilo. "In the past three years, Upper Blinkwater has already been able to generate about 90 percent of its electricity through photovoltaics. To make sure we do even better in the future, we will also be integrating small wind generators into the microgrid in a few weeks. Analyses have shown that there is enough wind in Upper Blinkwater. Therefore, we expect that in the future we will only need to use the diesel generator here very rarely and will be able to supply the households exclusively with sustainable electricity."

A CHANCE TO BREAK AWAY FROM POVERTY

Technologies such as microgrids not only enhance the sustainability of smaller and often remote communities, but they also give a much-needed boost to the economy, enhancing residents' quality of life. "It was amazing to see the economic activities that were triggered by the provision of electricity alone. When we came here for the first time, there was very little economic activity in this little community. A lot of the trade was actually barter," says Tshibvumo Sikhwivhilu, co-founder and Chief Executive Officer of Lamo Solar. "Now, four years down the line, we were taken aback by the changes. For example, there is a local carpenter who is able to make chairs and tables through renewable green electricity to provide and sell them. Now, those chairs may appear as, you know, a luxury or something to sit on because it is furniture, but the impact of having a chair far spans beyond what we see with our naked eye, because schools and children are able to gather at one place sitting on something that is a lot more comfortable and not under trees to learn. A small step to break themselves away from the cycle of poverty."

A SOLUTION FOR MANY VILLAGES

Upper Blinkwater is not an isolated case. In the Eastern Cape Province in South Africa alone, about 25 percent of rural villages are not connected to the electricity grid. Worldwide, around 1.2 billion people have no electricity and are therefore excluded in principle from many opportunities to live, trade and communicate with each other. Microgrids create new perspectives for people and are sustainable at the same time. Gaju sums it up: "The news in South Africa is full of reports about electricity shortages. Many people complain about loadshedding (temporary disconnection of electricity due to overload of the grid). We don't have that problem in Upper Blinkwater. Our electricity is stable."

STATE DEVELOPMENT CORPORATION OF THURINGIA (LEG THÜRINGEN)/ THURINGIA INTERNATIONAL IN SOUTHERN AFRICA



Bilateral trade between the Free State of Thuringia and the Republic of South Africa amounted to €174.8 million in 2022, with exports from Thuringia to South Africa at €101.53 million and imports from South Africa at €73.27 million. Main export products were motor vehicles and –parts, rubber and plastic products, machinery and pharmaceutical products, while Thuringia's main imports from South Africa were machinery, motor vehicles and parts, metals and agricultural products.

We saw yet another action-packed year of Thuringia's activities with and in the Southern African region!

AFRICA HEALTH/MEDLAB AFRICA

The State Development Corporation of Thuringia (LEG Thüringen) participated in an official joint pavilion at the Africa Health Exhibition / Medlab Africa in Johannesburg from 26 to 28 October 2022, showcasing their stronghold in the field of healthcare and life science. Thuringian exhibitors, like ASKION GmbH, fzmb GmbH Research Centre for Medical Technology and Biotechnology, INTER-ARRAY®, HEMA Orthopädische Systeme GmbH, Königsee Implantate GmbH, Medipan GmbH and Werkzeugbau Ruhla GmbH enjoyed three days of fruitful conversations, new leads and business opportunities at Africa's largest medical trade event. Our Chamber also organised B2B meetings with local industry representatives and decision-makers in Johannesburg and Cape Town.













LÄNDERWIRTSCHAFTSTAG SÜDLICHES AFRIKA

Southern Africa is by far Thuringia's most important export market in Africa. On 1 March 2023, we looked into business opportunities and the economic landscapes of South Africa, Namibia, Zambia and Angola, during Thüringen International's "Länderwirtschaftstag südliches Afrika" and highlighted the priority sectors water, energy, hydrogen as well as sales and distribution strategies. The event concluded with a panel discussion of Thuringian companies that have successfully entered the Southern African markets, sharing their findings and experiences.



INTERNATIONAL FOREIGN TRADE DAY

This event was followed by LEG Thüringen's annual flagship event, the 15th Thüringer Außenwirtschaftstag/International Trade Day where Thuringian businesses meet with trade and economic representative from all over the world. Some 300 participants attended this exciting event with Jan Berger as the keynote speaker. It was a great opportunity to network, make new contacts and re-connect with existing ones.





CHAMPIONSMEET

Following the two events in Jena, I had the opportunity to attend ChampionsMEET in Erfurt - a meeting of top Thuringian companies. Their success reflects the economic attractiveness of the Free State. "Hidden Champions - Thuringia's world market and technology leaders" presented a selection of high-performance companies: market and technology leaders that impress with their products and services in Germany, Europe and worldwide. The project is a joint initiative of the Thuringian Ministry of Economic Affairs and the State Development Corporation of Thuringia.

In extensive research, almost 90 companies in Thuringia were identified. Among them are world-renowned companies such as Carl Zeiss and JENOPTIK but also "hidden champions" such as Häcker Automation GmbH or ASKION GmbH Biobanking and Königsee Implantate.

FUNKWERK

After a few years of planning and cancellations due to Covid, Thuringia's Funkwerk Systems GmbH was finally able to showcase their latest technologies and innovations at Africa's largest and most established transport event on the continent: Africa Rail 2023 in June 2023 at the Sandton Convention Centre in Johannesburg. Funkwerk was included in the official German Pavilion hosted by the Federal Ministry for Economics and Climate Action (BMWK) in cooperation with the AUMA and the Verband der Bahnindustrie in Deutschland (VDB) e.V. (German Railway Industry Association).

Funkwerk has emerged as a leader in the growing markets of mobility and digital infrastructure. With tailor-made concepts, Funkwerk controls and rationalises operational processes, primarily for the railway industry and public transport, as well as development and realisation of mobility concepts for the public domain. Funkwerk develops and markets innovative communication solutions for railways.









THURINGIAN BUSINESS DELEGATION

The highlight of 2023 was the very successful working visit of the Minister of Economics, Science and Digital Society, Mr Wolfgang Tiefensee and the CEO of the State Development Corporation of Thuringia, Mr Andreas Krey and their business delegation to Namibia and South Africa.

We can all look back on endless impressions and experiences in these two beautiful countries; so many fruitful meetings, discussions and interactions with representatives from business, academia and politics.

This highlight in combination with other Thuringian delegates and their companies already active and expanding into the Southern African Markets, including MAXX-Solar Energie, Polycare, Maximator Hydrogen GmbH and IGS Ingenieure, surely highlights Thuringia's strong interest and ongoing commitment to our region.

Bavarian imports from South Africa amounted to approximately 1.8 billion euros, showcasing the depth of economic collaboration between these regions.

The bilateral trade volume between Germany and South Africa in 2021 was an impressive 20.3 billion euros. German imports surged to 8.0 billion euros, marking a substantial 44.7 percent increase from the previous year. Key export goods from Germany included motor vehicles and parts, machines, raw materials, non-ferrous metals, and food. German exports in 2021 amounted to 8.0 billion euros, reflecting the diverse and dynamic nature of this trade relationship.

IFAT Africa 2023: A platform for collaboration

A highlight in 2023 was the IFAT Africa trade fair hosted in Johannesburg from 5 to 7 July. This event, which is organised by Messe München GmbH, is the leading trade fair in Southern Africa for water, sewage, refuse, and recycling. IFAT Africa 2023 welcomed 4,500 visitors and hosted 125 exhibitors from 17 countries and regions.

The 5th German Business Round Table Botswana hosted by the German Ambassador to Botswana, H.E. Margit Hellwig-Bötte, took place in June 2023. The main topic of discussion was Botswana's new Public Procurement Regulations and how they affect German businesses and entrepreneurs.

From 5 to 10 June, Mozambique and Namibia hosted a delegation from Saxony, headed by Martin Dulig, State Minister for Economic Affairs, Labour and Transport and Vice Prime Minister of the Free State of Saxony. From 17 to 22 July 2023 the SAGCC organised and hosted a delegation of decision-makers from the DRC to Johannesburg, South Africa in cooperation with the GIZ DRC Office. The delegation included His Majesty, the Grand Chief of Kaponda, the President of the Chamber of Mines, Mr Louis Watum, Vice President of FEC (Congolese Chamber of Enterprises), Mr Eric Monga, and Madame Lucie Mujinga, Mayor of the Municipality Ruashi, amongst others.

The aim of the delegation was two-fold: to allow for peer exchange on community management and destination marketing with local municipalities as well as to engage with private industry on market potential in the DRC. Our amazing partners and member companies in the mining, water, energy, and agriculture sectors were highlighted during our various company visits to wec projects, ifm, Zest Weg Group, Schauenburg Systems, and KSB Pumps and Valves. In total, 10 delegation trips into the Southern African region were organised in 2023.

We are excited about the increased interest from the EU in the countries of Botswana and Mozambique, as they host their first EU Business Forums in 2023: the <u>EU-Botswana Business Forum</u> in October 2023 and the EU-Mozambique Global Gateway Investment Forum in November 2023.


To offer German companies wanting to enter the Southern African markets partly funded consultancies, the AHK Southern Africa registered as a German Federal Office of Economics and Export Control (BAFA) listed consulting firm within the framework of the Beratungsgutscheine Afrika (Africa Consulting Vouchers). Through this new funding mechanism, the Federal Ministry for Economic Affairs and Climate Protection (BMWK) promotes the use of external advisory service providers, such as the SAGCC, for various consultancy services which enable German companies wanting to enter new markets to obtain needs-oriented advice on potential economic projects in Africa.

MAPUTO, MOZAMBIQUE

Building local networks to strengthen bilateral relations and promote trade between Mozambique and Germany is one of the core strategies of the Maputo office. In this way, German companies, including member companies of the SAGCC, can expect the best support in the developing Mozambican market and benefit from a strong local network on the ground.

Requests for information and market entry consultations increased consistently in 2022-23 and is reflected in the number of contacts, discussions, and on-site visits in Maputo. There is also a corresponding increase in interest in Mozambique as a 'new' potential market option – both for sales and investments as well as for sourcing products, goods, and services.

Our member survey conducted in early 2022 and again in 2023, identified Mozambique as one of the countries in Southern Africa with the greatest growth potential for German companies.

Mozambique's leading trade fair, FACIM 2023, took place from 28 August to 3 September. This multisectoral trade fair was organised by the Mozambican Ministry of Industry and Trade through the Investment and Export Promotion Agency (APIEX) and hosted at the Ricatla International Trade Fair Centre in the Marracuene district of Maputo province.

Themed "Diversifying the national economy in the context of continental integration", the 58th edition of FACIM aimed to showcase the country's production and export potential and promote business and investment opportunities in the various economic segments. FACIM 2023 featured more than 2,500 domestic and foreign exhibitors from about 25 countries, including 450 foreign companies, spread across ten exhibition halls and open spaces. Italy, Portugal, Brazil, and South Africa were well represented with national pavilions, including various South African investment authorities. All Mozambican ministries, provinces and state-owned

LUSAKA, ZAMBIA

The "New Dawn government" under President Hichilema, has embarked on a course of ambitious political, economic, fiscal and social reforms, relying primarily on the private sector driven by sustainable growth and investment. Politically and economically, some decisive changes are to be expected and Zambia is once again moving into the focus of international companies and investors.

ambia offers diverse opportunities for German suppliers in agriculture, food processing, energy, industry, mining, and tourism. Located in the heart of Africa, this 'landlinked' country, as President Hichilema refers to it, is well-positioned within the AfCFTA.Building local networks to strengthen bilateral relations and promote trade between Zambia and Germany is one of the core strategies of the office in Lusaka. In this way, German companies can expect the best support in developing Zambian markets and benefit from a strong local network on the ground. In addition, the Lusaka office plays a proactive role in the EU-Zambian Business Club to ensure good contacts with the private sector.

A NEW REGIONAL REPRESENTATIVE

In July 2023, the SAGCC appointed a new Regional Representative for Zambia, Mr Hassan Wehbe, who has been living and working in Lusaka since December 2021.

Through his previous experience in the country, he has focused on introducing innovative German companies in construction, energy, and waste management to the Zambian market. This has enabled him to build and expand valuable networks in the mining, agriculture, and water resource management sectors and he has forged close relationships with a wide range of local public and private actors and stakeholders.

With a hybrid research and administrative background, Mr Wehbe has valuable insights into the political-economic dynamics of Zambia that can contribute to a realistic evaluation and implementation of local projects and ventures. With this understanding of the political, economic, and cultural conditions in Zambia, he is successfully supporting the market entry goals of German businesses.

Mr Wehbe is fluent in German, English, Arabic, and Spanish, and is also familiar with local Bantu languages such as Nyanja and Bemba.

BUSINESS DELEGATION

From the 25th to the 29th September 2023, the SAGCC finally brought its first delegation to Zambia since the pandemic. The SAGCC's Zambia Office, on behalf of the Federal Ministry of Economics and Climate Action (BMWK) and in cooperation with the Afrika-Verein der deutschen Wirtschaft and iMOVE, hosted a business initiation trip with six German companies active in the Training & Educational Sectors in Lusaka and Kitwe, Zambia. The focus was on understanding Zambia's evolving business environment, particularly within the TVET and educational sectors, as well as creating credible business linkages for the German delegates with their Zambian counterparts.

In Kitwe, a presentation and networking event facilitated interactions between guests, keynote speakers, most notably Dr. Christopher Chilese, Head of Training at the Mopani Central Training Centre, experts, and stakeholders, including the Mayor of Kitwe, Her Worship Mpasa Mwaya.

HISTORIC STATE VISIT: GERMAN FEDERAL PRESIDENT IN ZAMBIA

German Federal President Frank-Walter Steinmeier, together with a high-ranking business delegation, embarked on an official state visit to Zambia on the 01. – 02.11.23, marking a significant moment in the diplomatic relations between Germany and Zambia. This visit, the first of its kind by a German Federal President and the first official German state visit to Zambia in recent times, signifies a strengthening of ties between the two nations.

During this historic visit, President Steinmeier engaged in a series of discussions with Zambian President Hichilema. Highlighting the importance of education and vocational training, President Steinmeier also visited the Fountain Gate Crafts & Trades School. This vocational college, which benefits from the involvement of the Chamber of Skilled Crafts of Frankfurt-Rhine-Main, symbolises the collaborative efforts in education and skills development between the two countries.

Parallel to the presidential discussions on 01.11.2023, a significant networking and roundtable event was organised by the German Embassy in Zambia. This event served as a platform for the accompanying business delegation led by German Parliamentary State Secretary Michael Kellner (MP), which included prominent figures from the automotive, infrastructure development, and innovation sectors, to interact with their Zambian counterparts from both the private sector and on ministerial levels. Before the networking and roundtable event, the Southern African-German Chamber of Commerce and Industry (SAGCC) conducted an internal briefing for the delegates.

Participants commented on the discussions as both invoking and positive, reflecting the potential for future collaborations. The SAGCC has expressed optimism, anticipating a noticeable increase in engagement from the German private sector in Zambia by mid-2024. This visit not only marks a historic moment but also paves the way for enhanced economic and diplomatic cooperation between Germany and Zambia.

HARARE, ZIMBABWE

Zimbabwe continues to grapple with significant economic and political challenges. Government's promises made nearly six years ago remain largely unfulfilled, despite efforts to adopt a more pragmatic approach towards business. The slogan "Zimbabwe is open for business" rings hollow as the business community is plagued by a pervasive sense of negativity, with many companies merely trying to survive. Various issues, including currency volatility, inflation, a strained credit environment, policy inconsistencies, complex taxation systems, and unreliable utility services, particularly in the electricity sector, hinder business performance. According to the World Bank's Ease of Doing Business Index, Zimbabwe ranks 140th out of 190 countries, further damaging its international reputation and discouraging much-needed foreign investment. There is, however, a noticeable positive trend in increasing exports.

Ithough unemployment remains alarmingly high, officially around 90%, the informal sector is thriving and contributes significantly to the GDP. The scarcity of job opportunities has resulted in a brain drain, particularly among young Zimbabweans, which has led to skills shortages in certain sectors. Remittances from Zimbabweans working abroad are a lifeline for many households and small businesses, reaching \$1.4 billion USD in 2021.

The Zimbabwean dollar continues to depreciate against major currencies – from parity with the US dollar at its introduction in 2019 to an official rate of 5,400 and 8,000 on the parallel market by the end of September 2023. This has fuelled the triple-digit inflation seen in June 2023, and has disproportionately impacted lower-income individuals by eroding their purchasing power. External factors such as the Ukraine crisis also contribute to rising prices. While there is growing concern that Zimbabwe may face another hyperinflation crisis, possibly worse than the one in 2008, widespread use of the US dollar has somewhat mitigated the impact of inflation. The Zimbabwe Dollar's volatility is jeopardising the government's goal of establishing it as the sole currency by 2025.

Economic prospects remain challenging; major financial institutions predict modest growth of 2-3% in 2023, driven by agriculture, mining, and services, particularly in the tourism sector. Macroeconomic uncertainties stemming from erratic policymaking, runaway inflation, a weakening currency, rising borrowing costs, and worsening electricity shortages are expected to stifle short-term growth. Addressing these economic challenges and achieving sustainable growth requires proactive and effective policies.

In the political sphere, repressive laws have further restricted the democratic space in Zimbabwe. The Criminal Law(Codification and Reform)Amendment Bill 2022, known as the Patriotic Bill, criminalises actions perceived as damaging to national interests or critical of the government, and grants

authorities broad powers to suppress opposition. The Private Voluntary Organisation Amendment Bill, while not yet enforced, limits political involvement of civil society groups and allows government to inerfere in their governance and activities.

The major event in 2023 was the harmonised elections held on 23 August, resulting in ZANU-PF and Emerson Mnangagwa securing victory. While ZANU-PF won 136 parliamentary seats, the main opposition party, Citizens Coalition for Change (CCC), secured 73 seats. ZANU-PF, however, just fell short of gaining a two thirds majority required for constitutional amendments. With 52.9 % of the votes, the president secured another five-year term in office. His main rival, Nelson Chamisa from the CCC, obtained 44% of the votes.

International election observers criticised the elections for lacking credibility, freedom, and fairness, with even SADC observers openly denouncing the flawed process. CCC contested the results but refrained from pursuing legal action due to concerns of judicial bias, instead appealing to SADC for a re-run, which is unlikely to succeed. Consequently, ZANU-PF is expected to maintain a firm grip on power.

These developments may leave a negative impression on foreign investments and could impact planned debt restructuring efforts with Bretton Woods Institutions and the African Development Bank. A lack of fresh funding may limit Zimbabwe's growth potential, and re-engagement with the international community, including the Commonwealth, may be hindered. Additionally, continued and a potential increase in emigration may exacerbate skill shortages.

Despite these challenges, Zimbabwe possesses significant growth and development potential. Stable political leadership, effective economic policies, and responsible governance can help the country overcome its obstacles and strive for a prosperous future. Investments in agriculture, mining, and tourism will be pivotal in transforming the economy and improving the lives of Zimbabwean citizens.

FRANKFURT, GERMANY

TRADE

2023, saw a positive upswing in German-Southern African business relations due to two key developments. Firstly, extensive coverage in German media of the German-African Business Summit (GABS) held in Johannesburg from December 6 to 8, 2022. The detailed insights shared about this event generated heightened interest among German entrepreneurs towards Southern African markets.

Secondly, ongoing discussions in Germany regarding the de-risking of China, coupled with market setbacks in Russia and Ukraine, prompted a shift in focus for German entrepreneurs in 2023. Seeking new opportunities, they began exploring alternative markets, with South Africa emerging prominently on their radar. This dual influence contributed to a strengthened and more dynamic engagement between German businesses and Southern Africa.

German exports to South Africa increased in the first half of the year 2023 to 5 billion euro (+4.9 %). Exports of German machinery, for example, increased about 19.6 percent to nearly 800 million euro.

In 2022, trade between Germany and South Africa reached a volume of 24.1 billion euro. German exports totaled 9.8 billion euro, while German imports amounted to 14.3 billion euro. Notably, German imports experienced a significant surge, registering a robust increase of 22.7 percent.

EVENTS

Demand for events and consulting related to the South African market experienced a notable uptick in 2023. The Frankfurt Representative played a pivotal role in advising interested German entrepreneurs at the "Mitteldeutscher Wirtschaftstag" in Erfurt, which attracted 150 participants and was organised by the Chambers of Commerce and Industry (CCIs) in the states of Saxony, Saxony-Anhalt, and Thuringia. The representative also participated in the "Aussenwirtschaftstag 23" in Duesseldorf, organised by the 16 CCIs in the state of North Rhine-Westphalia, which drew more than 600 participants.

In the last quarter of 2023, the Frankfurt representative is set to contribute to four more South African Consulting Days organised by German CCIs.

OUTLOOK

The overall outcome in 2023 is both encouraging and promising for a successful turn-over of German-South African trade in 2024. In conclusion, Frankfurt Representative, Walter Engelmann expresses gratitude to the dedicated teams in Johannesburg, Cape Town, and Durban, as well as the regional offices in Harare, Lusaka, and Maputo, for their close, fruitful, and efficient cooperation.

On 4 April 2023, AHK Southern Africa, in cooperation with Deutsche Messe AG, hosted the EMO Hannover Digital Press Conference South Africa. EMO Hannover, the world's leading trade fair for production technology, was held in Hanover, Germany, from 18 to 23 September 2023. It showcased the current state of the art in international production technology and also looked ahead to future developments.

South Africa is the second largest economy in Africa and also a key industrial centre and the largest automotive production hub. South Africa has an effective machine tool industry of its own, yet is also dependent on international partnerships. The main suppliers are China, Italy, Switzerland, South Korea and Germany. The attendance of EMO Hannover meant that South African trade visitors were treated to a comprehensive array of products from the top suppliers along the entire value chain and a wide range of products from many other countries

THE BRIGHT WORLD OF METALS

South Africa's National Foundry Technology Network (NFTN), along with the South African Institute of Foundrymen (SAIF) and the Aluminium Federation of South Africa (AFSA), showcased South Africa's metal casting capabilities and investment opportunities in Düsseldorf from 12-16 June 2023, at GMTN 2023: The Bright World of Metals. The pavilion was supported by the Department of Trade, Industry and Competition (the dtic), the Council for Scientific and Industrial Research (CSIR) together with the National Foundry Technology Network (NFTN).

The South African National Foundry Pavilion hosted an evening of networking and innovation at the GIFA 2023 with all South African exhibitors as well as representatives from the South African government. The participation aimed to promote localisation and technology transfer, identify the casting technologies and services that South African foundries need and develop better access to global markets.



IFAT AFRICA MAKES A COMEBACK

Messe München's IFAT Africa 2023, backfrom a four-year hiatus, welcomed around 4,500 representatives and visitors from the environmental technology sector and 125 exhibitors from 5 to 7 July. This fourth iteration of IFAT Africa saw industry stakeholders flocking to the Gallagher Convention Centre for a long-anticipated update on innovations, trends, challenges and solutions accompanied by well attended conferences and sessions.

AHK Southern Africa's SADC delegation to IFAT 2023 consisted of delegates from the Water and Sanitation Infrastructures Administration (AIAS), Mozambique and the Municipal Infrastructure Support Agent in South Africa. The trade fair provided the delegates with a unique opportunity to gain first-hand knowledge of the sector, valuable insights into the water, sewage, refuse and recycling sector and to identify potential customers and projects.

IFAT Africa 2023 was co-located with analytica Lab Africa, the only South African trade fair for the analysis, laboratory technology, and biotechnology sectors. The combined events attracted around 6,000 visitors and a considerable number of leading brands for three days of networking, knowledge sharing, and solution discovery.





SA AT ANUGA 2023

The Department of Trade, Industry and Competition organised a South African Pavilion for Anuga 2023, which took place from 7 to 11 October 2023. Anuga is the world's leading trade fair for food and beverages with over 7,800 international exhibitors from 118 countries and 140,000 attendees. The South African pavilion consisted of over 30 companies in the food, drinks and beverage industry. The trade fair had exciting panel discussions, informative presentations, inspiring best-practice examples and award ceremonies. MINING AND MINERAL RESOURCES

The Competence Centre for Mining and Mineral Resources (CC:MMR) is a key point of contact for German companies in the mining sector of Southern Africa and is responsible for trade relations that contribute to securing and diversifying German resources supply and the promotion of attractive German technology, products, and services. The CC:MMR is a part of the larger German Mining Network that serves as a platform for international interaction between German companies and institutions dealing with mineral resources.

PROMOTING GERMAN MINING TECHNOLOGY THROUGH TRADE FAIRS AND EVENT PARTICIPATION

Investing in African Mining Indaba - Cape Town, South Africa

The largest mining investment event in Africa, Mining Indaba, took place from 6 to 9 February 2023 and welcomed over 8,100 delegates. The interest of German companies has increased significantly, with this year's German Pavilion hosting 19 exhibitors. The CC:MMR was positioned at the information stand of the German Pavilion and served as a key point of contact for mining in Southern Africa, and welcomed the attendance of Ms Susanne Szech-Koundouros, Deputy Director General for Raw Materials Policy, Resource Efficiency, Circular Economy of the German Federal Ministry for Economic Affairs and Climate Action (BMWK) and Dr Peter Buchholz, Head of German Mineral Resources Agency (DERA).

Alongside the conference, the CC:MMR co-hosted a German-French Afternoon Symposium with DERA, the French South African Chamber of Commerce and Industry, and the French Geological Survey (BRGM) themed "The Future of Mining in Africa – Sustainability, Innovative Technology and the Energy Transition", aimed at increasing market presence and positioning of German OEMs and investor support while showcasing collaboration and strategic partnerships in raw materials. The keynote address was delivered by H.E Sandra Kramer, Ambassador of EU Delegation to South Africa, and expert speakers on the topics of – The Role of Technology in Sustainable Mining, Supply Security of Energy Transition Metals and a panel discussion on Mining and the Energy Transition.













Mozambique Mining and Energy Conference, Maputo

CC:MMR attended the Mozambique Mining and Energy Conference (MMEC) on 26 to 27 April 2023 in Maputo, Mozambique under the theme "Utilizing Mozambique's Natural Resources for Transformational and Sustainable Economic Development". The MMEC highlighted the immense potential of Mozambique's mineral and energy resources for sustainable economic development and served as an excellent platform for the CC:MMR to reconnect and strengthen relationships with existing mining partners and stakeholders in Mozambique.


DRC Mining Week 2023 - Lubumbashi, DR Congo

The DRC Mining Week is a flagship trade fair for the CC:MMR. The trade fair took place from 13 - 16 June 2023 in Lubumbashi, DRC. The conference focused on global trends and opportunities in the DRC's mining ecosystem. The CCMR was positioned at the information stand of the German Pavilion and was a key point of connection for stakeholders interested in engaging with German OEMs.

The German Embassy in DRC collaborated with the CCMR to host a networking reception event in Lubumbashi, DRC. CCMR arranged a site visit to Somika Copper Mine, the processing plant and copper stripping section in Kipushi. The Somika Kipushi plant was commissioned in 2001, making it one of the first processing plants in the DRC and a key producer of Copper Cathodes and Cobalt (II) Hydroxide.









International Mines Rescue Body Conference - Sun City, South Africa

This year Mines Rescue South Africa celebrated their 100th anniversary at the International Mines Rescue Body Conference which took place from 1 – 3 October in Sun City, South Africa. The occasion signifies a century of dedicated efforts and advancements in ensuring the safety and wellbeing of miners, a remarkable achievement for the mining sector and the heroes of emergency mine rescue. The conference welcomed over 500 delegates, both nationally and from abroad and all major mining companies and focused on showcasing advancements in mine health and safety. The CC:MMR participated in the conference with an information stand alongside other member companies – Schauenburg Systems and Dräger.

Critical Minerals Africa Conference -Cape Town, South Africa

As a strategic partner of the <u>Critical Minerals Africa Conference</u>, which took place concurrently with the African Energy Week during 17 - 19 October in Cape Town South Africa, the CC:MMR was represented by Selleen Sewpershad on a panel session focusing on Environmental, Social and Governance (ESG) and Building More Value in Africa's Critical Minerals Production. The session addressed the integration of ESG principles into Africa's existing mining exploration and production activities.

MINING DELEGATIONS

Business initiation trip to Namibia and Botswana for German suppliers in the mining sector

From 4 to 8 September 2023, CC:MMR conducted a business initiation trip to Namibia and Botswana within the framework of the Foreign Market Entry Programme (MEP) for small and medium-sized German enterprises (SMEs). The delegation was organised in cooperation with Enviacon and VDMA Mining and carried out with the support of the local partners in Namibia – Namibia Investment Promotion and Development Board, Geological Survey of Namibia, Chamber of Mines of Namibia; and in Botswana – Botswana Investment and Trade Centre, Botswana Geoscience Institute, Botswana Chamber of Mines.

The delegation consisted of eight German companies offering a range of products and services. These included electrification and automation technology; engineering and consultancy services for energy; geotechnical, formwork and trench shoring systems for the building industry; suppliers of pumps and valves; processing and transporting of materials; and smart conveyor systems with spillage control. The five-day programme provided the companies with information on the industry and situation and enabled them to identify potential customers, local partners and projects as required.

AfricaMaVal - Building EU-Africa partnerships on sustainable raw materials value chain

"The AfricaMaVal initiative is paving the way for sustainable mineral sourcing practices in Africa, fostering collaboration between Europe and Africa, and promoting responsible development that aligns with global ESG standards."

The consortium partners, alongside advisory board members, the stakeholder's network and the African Minerals Development Centre, convened in Entebbe, Uganda from 5 - 6 June 2023 for the 2nd AfricaMaVal Consortium Meeting. The CC:MMR is responsible for compiling the National Regulatory Framework and Good Governance



Evaluation for 54 countries in Africa as part of Work Package 7 – Responsible Investment Opportunities, led by the <u>Federal Institute</u> <u>for Geosciences and Natural Resources</u> (BGR). The year 2024 will be strategically significant for the AfricaMaVal initiative as it will witness the restitution of Country Case Studies, the release of country profiles outlining Artisanal and Small-Scale Mining (ASM) and mining regimes, as well as the organisation of road shows across the different Regions of Africa to introduce the project, showcase the B2B networking platform, and explore potential investment projects.

WORKING GROUP: MINING

The Competence Centre for Mining & Mineral Resources (CC:MMR) is the facilitator of the working group mining consisting of relevant mining industry stakeholders. This working group aims to link AHK member companies, mining industry bodies, universities, and government representatives to ensure that key decision-makers and industry are aligned to ensure a sustainable mining industry on one central platform. The working group mining committee collectively aims to create market transparency, foster collaboration, and communication, and support German mining technology in Southern Africa. Four sub-committees meet regularly to discuss key topics and report on progress and industry developments – 4IR, Legal and Compliance, Raw Materials & Mineral Processing, and Skills Development and R&D.

In terms of the 'Due Diligence Supply Chain Act', Timo Pleyer successfully hosted numerous workshops on this topic for potential South African exporters. A WORLD OF OPPORTUNITY.

FOOD AND AGRICULTURE

The Federal Ministry of Food and Agriculture (BMEL) has commissioned the Southern African-German Chamber of Commerce and Industry to establish a "Centre of Excellence for Food and Agriculture" as of the 1st of October 2021. The focus countries of the competence centre are South Africa, Mozambique, Zambia and Zimbabwe. The competence centre is to promote economic and entrepreneurial cooperation in the field of food (processed and unprocessed food) as well as agricultural technology between Germany and the four countries in Southern Africa. The BMEL finances the services of the competence centre in order to make them more accessible and cost-effective for German enterprises to enter these markets.

GABS - PANEL: MODERNISATION OF AGRICULTURE

Agribusiness, the sector with the greatest potential in Africa, was one of the main themes at the 4th German-African Business Summit (GABS) held in Sandton, Johannesburg from 6 to 8 December 2022. The Chamber's Agriculture Competence Centre organised a panel discussion on modernisation of agriculture on 7 December 2022 with Mark Taylor, National Operations Manager, Lepharo NPC as panel moderator and Prof. Moses Azong Cho, Chief Researcher, Advanced Agriculture and Food Cluster, CSIR who gave the keynote address. The panel included Frank Nordmann, Co-Chair, German Agribusiness Alliance and General Manager Key Accounts and Sustainable Development Grimme Landmaschinenfabrik GmbH & Co. KG, Kobus Meintjes, Country Commercial Lead SA, Bayer Pty. LTD. South Africa; Pieter Pienaar, Managing Director, Informed Decisions; and, Tobi Akinbiyi, Managing Director, DRONE 9JA.

The panel went very well with positive feedback for KS Southern Africa. There have been discussions about a possible joint project between CSIR, Siemens, Drone 9JA and Lepharo NPC.

10TH FOREIGN TRADE DAY OF THE AGRICULTURAL AND FOOD INDUSTRY

The Außenwirtschaftstag der Agrar- und Ernährungswirtschaft (10th biannual Foreign Trade Day of the Agricultural and Food Industry) was held on 13 June at the Federal Foreign Office in Berlin. The aim of the forum is to share knowledge with food and agriculture companies about exciting foreign markets and exchange views with political decision-makers in these markets.

Africa was not forgotten at this event. During his keynote address, Mr Cem Özdemir, Federal Minister of Food and Agriculture, emphasised that the aim is to create additional sales markets for the agriculture and food industry, especially in the neighbouring continent Africa. In doing so, Germany wants to engage in fair trade and not destroy local markets; relations should be based on partnerships.

There was also a special country focus on South Africa. The Competence Centre for Food and Agriculture was honoured to participate in this South African forum. Danilla Van Jaarsveldt presented on the current economic situation as well as the opportunities for German companies in the agricultural sector in South Africa.

We applaud their determination and are excited about the opportunities for these trailblazers.

ANOTHER YEAR OF COLLABORATING TOWARDS GIVING AND INSPIRING YOUNG MINDS

In celebrating our 70th anniversary in 2022, we auctioned off the Arminia Bielefeld soccer jersey, and the proceeds benefitted the Dreamleagues, which supports ten junior soccer teams in Kagiso, Johannesburg. The Arminia Bielefeld soccer team representatives presented soccer kits to delighted Shongi coaches on 19 June 2023, an initiative that has positively impacted over 100 children.



In inspiring commitment to education, we collaborated with the Winnie Radebe Foundation (NPO) to provide shoes from the MyWalk Initiative to 179 learners at Lufhereng Primary and Protea Glen Secondary Schools in Soweto. CORPORATE RESPONSIBILITY

Our aim as specialised premium suppliers is clear: We want to become leaders in the development of sustainable refrigeration. We want to reduce the environmental impact of our premium Liebherr products along their life cycle as much as possible. In this regard, we have concentrated on four fields of action: materials, production, use phase and finally recycling.

A MILESTONE IN THE DEVELOPMENT OF REFRIGERATION AND FREEZING!

luRoX insulates using a vacuum in combination with finely ground lava stone, known as perlite, instead of conventional PU foam.


We have established that this unique insulation technology is ready for the market and have launched the FNb 5056 freezer with BluRoX in the door as a hybrid solution for the German market. We have continued refining them and focusing on a more ecologically sound product design.

As for the materials that we use, we want to reduce the impact of their use on the environment and prepare our products for a circular economy. In other words, we want to use more renewable and recycled materials in our products and reduce the variety of materials used.

In BluRoX, for example, the perlite used is a raw material that nature provides us with in almost unlimited quantities, compared to the production of conventional insulating materials from petroleum-based polyurethane, the entire process – from the extraction of the lava stone to its use as an insulating material – takes up fewer resources.







The material is completely safe in relation to human health. For instance, it is also used in a similar form in the beverage industry for filtering apple juice.

In terms of energy efficiency, a vacuum offers the best possible insulation. Due to its crystalline microstructure, perlite has very low thermal conductivity. This combination creates an outstandingly energy-efficient yet compact solution for cold insulation.

To facilitate easy reparability, the technical element of a future full-vacuum appliance will be compact and modularly installed in the base – in a replaceable module. If, after many years of use, a BluRoX appliance is no longer performing at its best, or in the event that a problem arises, the housing can still be used and the technical module can be replaced quickly – without downtime.

Our long-term aim is to achieve a circular economy at the end of an appliance's long service life. The goal is to design our products in such a way that used materials can be reused.

The second field of action is the environmentally conscious manufacturing of our appliances. We want to reduce energy consumption at our factories and make greater use of renewable energy sources. Apart from CO_2 emissions, we are reducing our environmental impact by using water responsibly and avoiding waste.

We were awarded the EcoVadis gold medal in 2022 for what we have achieved so far. By achieving a total score of 73 points, our global production sites are among the top 3 percent of all companies evaluated by EcoVadis worldwide.

This includes the plant in Ochsenhausen, where the BluRoX appliances are manufactured. We are currently working on the further industrialisation of BluRoX technology at this production plant and are adapting it to the new process. The completely new design of the product and the innovative technology require an entirely new approach – not only in terms of the production processes themselves, but also for the procedures for measuring quality or similar methods that still need to be developed.

After having spent more than ten years developing the technology, we will certainly be taking great consideration in increasing the capacities step by step.

What factors can we influence to make the use phase of refrigerators and freezers as resource-efficient as possible? Energy consumption is one of the factors that have the greatest impact on the environment – after all, our appliances are in use 24 hours a day, 7 days a week!

Consequently, our efforts to improve the energy efficiency of our existing high-end products are ongoing and unrelenting. We pay attention to maximum service life and easy repairability – supported by fast and effective customer service.

Once a BluRoX refrigerator or freezer has reached the end of its service life, the perlite can be removed and reused without significant reprocessing.

Moreover, because the BluRoX insulation is not bonded to the surrounding components, the outer shell and inner container can also be easily reprocessed and reused. This homogeneous separation of materials is what we are trying to achieve.

CLIMATE AND ENVIRONMENT

THE ENERGY, WATER AND WASTE NEXUS

The Competence Centre: Climate and Environment (CC:CE) supports businesses from Germany and Southern Africa, who seek to participate in the dynamic regional sustainable energy, water and waste markets. The CC:CE provides market information, supports companies in market entry and expansion, carries out activities geared towards developing the market, and functions as a platform for sector representation and cooperation. The CC:CE is working together with the private and public sectors to contribute towards stimulating the transition towards a greener and more resource efficient economy. The CC:CE encompasses three portfolios, namely sustainable energy, water and waste. SAGCC experts for these portfolios align their project planning and implementation to offer comprehensive support in the area of climate and environment to members and the private sector at large.

SUSTAINABLE ENERGY PORTFOLIO

In the past year, CC:CE Energy Portfolio's work centred on supporting the emergence of a green hydrogen industry in Southern Africa. The focus was always on the opportunities and challenges of the private sector, and getting businesses involved in the development of this new industry. As the service hub of the International Hydrogen Ramp-Up Program H2Uppp for Namibia and South Africa, the CC:CE identified a pipeline of more than a dozen hydrogen projects for possible funding via Public-Private-Partnership. Furthermore, we continued to support the private sector outreach of the bilateral hydrogen support programme H2.SA, building relationships between stakeholders across the green hydrogen value chain to further cooperation and business development.

Through the implementation of the German Energy Solutions Initiative's consortium building instrument, the CC:CE was able to directly support innovative hydrogen projects in Namibia and South Africa.

WATER AND WASTE PORTFOLIOS

To stimulate industrial resource efficiency in the region, the German Federal Ministry of the Environment, Conservation, Nuclear Security and Consumer Protection (BMUV) funded an expert-led resource efficiency workshop and individual coaching sessions for six companies in South Africa and Namibia.¹ Following the resource efficiency assessments in August and September 2023, BMW Group Rosslyn Plant, Mpact Corrugated Epping (Cape Town) and Mpact Corrugated Walvis Bay (Namibia) wasted no time to begin with the implementation of the recommended measures at their plants.

The Mpact Group could demonstrate significant water savings as a direct result of the project:

Mpact Corrugated Epping saved 401 kL of municipal water in the boiler system within the first seven months of 2023. This translates to a 4% water saving of the total expected boiler water consumption!

Mpact Corrugated Walvis Bay saved 506 kL water in the 11 months following the resource efficiency assessment conducted in August 2022, amounting to 13% of the plant's total water consumption!

In the first quarter of 2023 we focused on bringing German technological solutions for the public water supply and wastewater treatment to South Africa. Together with the German Water Partnership e.V. as our cooperation partner and supported by our local partners Water Institute of Southern Africa (WISA), Consulting Engineers South Africa (CESA), South African Local Government Association (SALGA) and Municipal Infrastructure Support Agent (MISA), we facilitated the collaboration between eight German companies and government institutions to explore

business opportunities in water and sanitation provision in urban and rural areas. The project was funded by the Foreign Market Entry Programme of the German Federal Ministry of Economic Affairs and Climate Action (BMWK).

We also support the public water sector in learning about new technologies and providing opportunities for public employed officials to further their professional development. Furthering the public sector's knowledge base about best practice water management practice stimulates the uptake of new technologies.

As part of the regional partnership between the German province of Lower Saxony and the Eastern Cape Province in South Africa, The SAGCC partnered with the Deutsche Management Akademie Niedersachsen (DMAN) and SALGA in bringing 15 water managers operating in the public sector in the Eastern Cape province in South Africa to Germany for a five-day technical training programme. The training took place on 10-15 September 2023 in Celle and focused on the professional development of the participants in the field of water supply and wastewater management, as well as storm water management and flood prevention. The Lower Saxony Ministry of Environment, Energy and Climate Protection funded the training. The participants enjoyed a varied programme, which included visits to the Oldenburgisch-Ostfriesischen Wasserverband (00WV) in Nethen (a municipal water supply company) and a guided visit at Hamburg Wastewater Treatment Plant.

CIRCULAR ECONOMY EXPERT

The principle and adoption of a circular economy has gained significant importance for the Southern African economy. It addresses the challenges of finite resource scarcity and waste management. South Africa, like many other countries, faces the depletion of natural resources and struggles with the environmental impact of linear production and consumption models. Embracing a circular economy approach allows for more efficient use of resources, reduced waste generation and environmental degradation.

In March 2023, a sector expert was appointed to promote circular economy business opportunities for German companies in Southern Africa. The sector expert provides valuable support by offering:

Knowledge and Networking:

The expert has local industry knowledge and networks with key stakeholders. They offer insights into the circular economy landscape, industry trends, and viable business opportunities in both public and private sectors. They also use their engineering expertise and project and corporate finance experience networks to assess local opportunities by leveraging German partner associations and the Africa Business Network Co-ordination Office in Berlin.

Business Opportunity Information:

The expert collaborates with local businesses to gather information on circular economy opportunities, including those in the public sector through bids and tenders. This information is summarised in fact sheets and shared with interested German companies.

Facilitating B2B Meetings:

When German companies show interest in circular economy opportunities, the sector expert coordinates business-to-business (B2B) meetings between German companies and local stakeholders to encourage collaborations. The sector expert has actively participated and hosted panel speaker events at various Circular Economy events, fostering relationships with industry associations in paper, plastics, waste, water, and building sectors, amongst others.

OUTLOOK

In 2023/2024 the water portfolio will focus on water and wastewater management in the agri-processing sector. Together with the German Water Partnership e.V. as our cooperation partner, we will bring German water sector companies to South Africa to explore business opportunities in this industrial sector.

Continuing our cooperation with the 'Energy Solutions Made in Germany' initiative, we will take a closer look at the renewable energy markets in Zambia and Botswana. In particular to link German photovoltaic businesses with high-potential costumers identified by the Project Development Programme of the Energy Solutions Initiative.

In our continued cooperation with H2Uppp, the focus will be on the implementation of Public-Private-Partnership projects in Namibia and South Africa. Thus providing hydrogen ventures with co-financing for their early development stage. In addition, we intend to identify further viable business models related to green hydrogen via design thinking events with the private sector.
