Dear readers,

German Sri Lankan business relations are on a good way. While Sri Lankan exports to Germany increased by 9% during the first half of the year 2019, German exports to Sri Lanka rose by 4%, during the last 2 months even by 13%. In the frame of a recently conducted business survey by the Delegation of German Industry and Commerce in Sri Lanka (AHK Sri Lanka), 62.5% of the companies declared to have achieved their business targets in 2018. Regarding the outlook for the Sri Lankan economy, 50% stated that the economy will stay unchanged or improve. Regarding their respective industries, German companies in Sri Lanka evaluated the outlook more positively. About 75% stated that their industry will stay unchanged or improve, about 44% think prospects for their industry will improve.

147 German brands participated in the Top German Brands 2019 initiative, which reflects the growing interest of German companies to be strategic partners of their Sri Lankan counterparts. With the highest trade surplus in the world of about 228 bn Euro and 1.3 trillion Euro exports worldwide the German economy remained the world's export champion. German products stand for highest quality standards and outstanding innovation, German businessmen for fair business, reliability and long-term-partnership. As the official representative of German business AHK Sri Lanka is committed to a level playing field, transparency, fair and free trade. We are confident that there are a lot of opportunities of cooperation in the future.

For 2020 AHK Sri Lanka will organize a German business delegation, conference and B2B-meetings in Colombo in the field of sustainable mobility from 27th to 30th of January 2020. Furthermore, an incoming delegation from 24th to 27th of March 2020 to Colombo will be organized on energy efficiency in industry. In the context of the promotion of Sri Lankan exports, AHK Sri Lanka will organize delegation visits and pavilions at the world's leading fairs including Boot 2020 at Messe Duesseldorf, International Green Week 2020 at Messe Berlin.

Top German Brands 2019 - "Strategic partners of Sri Lanka"

147 German brands represented in the 6th edition of "Top German Brands Sri Lanka" event in presence of Minister of Development Strategies and International Trade Hon. Malik Samarawickrama, German Ambassador to Sri Lanka & Maldives H.E. Jörn Rohde and Chief Delegate of the Delegation of German Industry and Commerce in Sri Lanka, Mr. Andreas Hergenröther.

The event was organized by the Delegation of German Industry and Commerce in Sri Lanka (AHK Sri Lanka) with the support of the German embassy at the Hilton Colombo Residences on the 18th of September 2019.

Mr. Hergenröther, Chief Delegate of German Industry and Commerce in Sri Lanka, in his speech pointed out that "as the logistic hub in South Asia and future trade hub, Sri Lanka will offer in the near future more business opportunities than ever. Hence raising public awareness of German brands as strategic partners of Sri Lankan businesses is a key objective of our institution. We are overwhelmed by the support and engagement that we got by the German companies and by their Sri Lankan partners to organize this event."

During the event the participating top German brands had the opportunity to showcase their striking innovations in a promotional film series. A jury of representatives of Rupavahini TV, German Embassy and AHK Sri Lanka selected 10 companies. Best awarded video was from Germany's world market leader in industrial gases Linde, followed by AUDI and DHL.



Company Background

The survey mainly targeted CEOs, Managing Directors and Senior Managers. Around 47% of the German businesses in Sri Lanka have participated in the survey. The results of the 2019 survey indicate that most of the companies have been operating their business in Sri Lanka for more than 10 years (68.8%). According to the response rate regarding the field of business, the highest rate (37.5%) recorded the German business entities operating in the trading sector in Sri Lanka. Production and services companies equally joined the Business Confidence Survey in 2019 (31.3%). Most of the German companies operating in Sri Lanka are medium level enterprises with a staff between 50 and 200 employees (as a percentage 59.5%), large scale recorded 19% with over 200 employees and 21.5% are small and micro enterprises up to 50 employees.


Figure: Industry Sectors of German Companies participated in the survey



Business Satisfaction and Targets

According to the survey, 62.5% of the total respondents have achieved their business targets in 2018 while others were struggling to reach their business forecasts.

Economic Outlook

Regarding the business expectation of German companies in Sri Lanka, 50% of the respondents had a neutral or improving perception on the economic outlook. In terms of their industries, 75% continue to show positive attitudes towards their industries and business developments in 2019 and 2020.

Figure: General Economic Outlook





Figure: Economic Development of own Industry



Business Friendliness

It is a crucial topic in the business world to deal with government agencies and fulfill business requirements. According to the survey results, 75% of the German companies are having a negative perception about the public authorities in Sri Lanka. Only 25% believe that the public authorities are working efficiently and resolve their issues.

On the other hand, more than 56% of the responding companies stated that the transparency of the government tender procedures is neutral in their related business and 29% are believing the procedure should be more developed and transparent.

Figure: Efficiency of the public agencies





Figure: Transparency in public tender procedures




Investment Climate

Unlike last year, the survey recorded a slight decrease in the investment perception in 2019 compared to 2018 results. In 2018, 46% of the participants stated that their business operation in Sri Lanka is planning an investment at a new location in Sri Lanka within the next 2 years. However, in 2019, it showed only 37% optimistic responses. Most of the companies are in the state of evaluating their business environment and current risk.


Figure: Investments within next two years



Business Challenges

About 37.50% of the German companies identified that the political stability is a major challenge for their business operations in Sri Lanka. They have further identified the reliability of the legal framework as a challenge as well as the currency risk impact on their businesses. According to the survey results, most of the German companies are facing land and property regulations as a minor challenge. Under the business challenges, 60% of the companies responded that the process of registering products is not a challenge for them anymore.



August inflation rises to 3.4%



Headline inflation as measured by the year-on-year change in the National Consumer Price Index (NCPI, 2013=100)1 increased to 3.4% in August from 2.2% in July, the Central Bank said yesterday.

The low base that prevailed in the corresponding month of the previous year and the monthly increases of prices of items in both Food and Non-Food categories contributed to this increase. Meanwhile, in August, year-on-year Food and Non-food inflation recorded 0.6% and 5.65% respectively.

The change in the NCPI measured on an annual average basis increased marginally to 2% in August from 1.9% in July.

Monthly change of NCPI recorded 0.2% in August and which due to the price increases observed in the items of both Food and Non-Food categories.

Within the Food category, prices of banana, rice and fresh fish recorded increases. Moreover, within the Non-Food category, prices of the items in Transport; Alcoholic Beverages, Tobacco and Narcotics; Clothing and Footwear subcategories increased during the month.

The core inflation, which reflects the underlying inflation in the economy, declined to 5.9% in August from 6.1% in July on year-on-year basis. However, annual average core inflation increased to 5% in August from 4.7% in July. Source: 24/09/2019/ Daily FT

Hambantota International Port ties the knot with Ranong Port, Thailand

The Hambantota International Port (HIP) signed an agreement for port-to-port cooperation with the Ranong Port in Thailand. The partnership is a bid to build synergies between these two maritime locations.


Thailand is currently following a policy to boost trade with India, Bangladesh, and Sri Lanka under the framework of the Bay of Bengal Initiative for Multi-Sectoral Technical and Economic Cooperation (BIMSTEC). It recently signed an agreement to facilitate a new maritime route between the Krishnapatnam Port in India and Ranong Port.

"We are very happy to be a part of this initiative as it is looking at developing the BIMSTEC region to the benefit of all its partners. With HIP now coming strongly into this play, we can see it becoming an important nodal which will facilitate the movement of cargo not only in the region but also countries to the west of Sri Lanka," says Hambantota International Port Group (HIPG) CEO Ray Ren.

"As we develop these connections and become an active facilitator of a gamut of maritime services for which our multi-purpose port is now gearing itself, we expect to partner with international and Sri Lankan companies in port-related industries. The industrial zone, which will be situated adjacent to the docks in the bonded area of the Hambantota Port is a totally new offering for the region. It will also make HIP the gateway port for the southern region of Sri Lanka," says Ren.

The first phase of the agreement, with Ranong Port and HIPG would be to exchange information and cooperation have port management, operations, information technology, communication, port connectivity, port-related industries. investment promotion in order to enhance the development of the two ports. The possibilities of introducing coastal shipping between Ranong Port, Hambantota International Port. with a view to promoting bilateral trade, investment, and maritime transport logistics would be considered in the next steps.

The Joint Working Group Meeting will be organised every two years and each Party will take turns in hosting the biannual meeting," says HIPG General Manager – Commercial and Marketing Lance Zuo, who represented HIP at the signing ceremony.







Cabinet nod for \$ 20 b Hambantota refinery project by Singaporean firm

A massive investment worth \$ 20 billion for a mega refinery project in Hambantota by a Singaporean firm has been approved by the Cabinet.

International Trade and Development Strategies Minister, Malik Samarawickrama stated, "the Cabinet gave approval for a refinery and related products project by Sugih Energy International (SEI), Singapore at the Hambantota Port,". Further he mentioned, the Board of Investment (BOI) has approved the project proposal as well.

"The company will invest in two phases. In the first phase, they have committed an investment of \$14.8 billion for the refinery, and further \$4 to \$5 billion for petrochemical and other projects," he added.

The respective approvals are subject to Environment Impact Assessments (EIA), which will be jointly done with the other refinery project, with an investment of \$ 3.8 billion by Silver Park International Ltd., a Singapore registered firm which was previously approved.

Acknowledging that these projects will take at least three to four years to be fully operational with all the right environmental clearances, the Minister, along with Finance Minister Mangala Samaraweera, told a media conference that the fact is that these are all in the pipeline, and these investments have been committed.

Noting that Sri Lanka can be proud of its FDI achievements, which are now picking up, he said between 1978 and 2018, the FDI inflows to Sri Lanka were \$17.3 billion, and of that 35% of it came in the last four years.

"One-third of the total FDI since liberalisation of our economy has come in during just the past four years. This is a clear indication of the confidence that investors have in us, and the investment prospects in our country. These are all long-term sustainable development projects," he pointed out.

Minister Samarawickrama also said they were negotiating with the Government of India to have a joint venture, to ensure that the Mattala Airport is operated prominently.
