#### **3. Purposes and legal bases of the processing**

Your data will be collected to record your registration for events.

Your data will be processed on the basis of Article 6 (1) (b) GDPR. Please note that the event will be photographed and / or filmed. By participating in the event, you consent to the use of a photograph and / or the appearance of your person in videos for publication (print, online, social networks, etc.).

#### **4. Recipients or categories of recipients of personal data**

Your personal data will be transmitted to:

The GNZCC uses an event management system which is responsible for the handling of the registration process and the handling of ticket sales.

#### **5. Transfer of personal data to a third country**

By using our event management system, the data collected during the event registration will be stored in the USA.

#### **6. Duration of storage of personal data**

Your data will be stored until the end of the event. Legal retention periods may also require storage.

#### **7. Rights of persons affected**

Under the EU Data Protection Regulation, you have the following rights:

If your personal data are processed, you have the right to obtain information about the data stored about you (Art. 15 GDPR).

If incorrect personal data is processed, you are entitled to a correction (Art. 16 DSGVO).

If the legal prerequisites exist, you can request the deletion or limitation of the processing and appeal against the processing (Articles 17, 18 and 21 DSGVO).

Because the data processing is based on a contract but data processing is carried out automatically, you may have the right to transfer data (Art. 20 DSGVO).

If you make use of your rights mentioned above, the German-New Zealand Chamber of Commerce will check whether the legal requirements for this have been met.

#### **8. Withdrawal with consent**

If you have consented to the processing by the German-New Zealand Chamber of Commerce, you can revoke your consent at any time in the future. The legality of the data processing of your personal data carried out on the basis of the consent until the revocation is not affected by this.
