## Speech by Minister of Development Strategies and International Trade in the Parliament of Sri Lanka -8th May 2019-

Hon. Minister began his speech stating that the tragic event occurred on Easter Sunday could not diminish the courage of the Sri Lankans, yet, the incident made the people stronger and feel more united than ever before. With the leadership of the President and the Prime Minister, impressive counter-terrorism measures have already been taken and targeted international cooperation is being obtained wherever required.

It is now essential to rebuild the economy while working towards bringing normalcy to Sri Lanka with the cooperation of all stakeholders. Hon. Minister insists that encouraging international partners to keep doing business with local parties is crucial to help the economy bounce back. He further stated that Sri Lankans should show their commitment to international investors that the country is being made safe, whose support during challenging times like this will ensure that terrorism does not win, and Sri Lanka's quest for economic prosperity will not be beaten down. Hon. Minister thanked the private sector for how they have performed so far during the tough times while highlighting the cooperation needed from their end to minimize the economic fallout and maintain religious and ethnic harmony within the country.

It is believed that the private sector of the country could play a major role in helping the economy get through this challenging time like how they showed their efforts in the past during repeated terrorist attacks, catastrophic events such as tsunami and other natural disasters. Therefore, it is important that private sector and government work together to emerge out of this existing challenge.

Hon. Minister stated that formulating an assistance plan for the tourism industry has already been commenced. A few meetings with the tourism industry representatives have been held to come up with a suitable package. The Minister is confident that macroeconomic stability that has been created in Sri Lanka will enable the country to better withstand shocks of this nature.

By end March foreign reserves of Sri Lanka stood at US Dollars 7.6 Billion, which is sufficient for over 4 months of import cover. Exports and FDI reached alltime highs in 2018 and the trade deficit in February was the lowest monthly deficit in over 5 years. Inflation was well under control at 4.5% in April. The Rupee has appreciated by 3.0% during this year. Interest rates declined over 100 basis points this year and necessary measures have been taken to bring down borrowing costs even further by at least 2%, especially for SMEs. The fiscal position continues to strengthen, with a primary budget surplus of 0.6% of GDP in 2018 and a 1.5% surplus projected for 2019.

Hon. Minister concluded the speech stating the Parliamentarians' duty should be to preserve the democracy while leading the citizens into new frontiers of peace and prosperity.

In the frame of the "German Energy solutions" program of the German Ministry of Economic Affairs and Energy (BMWi), AHK Sri Lanka currently conducts a business delegation from Sri Lanka to Germany focusing on Bio energy, waste-to-energy and system integration. The business mission left on 6th May 2019 along with 8 Sri Lankan companies and 1 state university. The visiting firms will have opportunities to meet potential clients, attend for a conference with the expert speakers in the respective industries as well as site visits which will enable them to engage with new technologies.


#### **Economic Overview of Sri Lanka - 2018**

During 2018, the Sri Lankan economy confronted many global and domestic disturbances which caused to achieve a moderate economic growth rate which grew at 3.2%, compared to 3.4% in 2017. This growth was largely supported by services activities that expanded by 4.7% and the recovery in agriculture activities, which recorded a growth of 4.8%. Industry activities slowed down significantly to 0.9% during the year, mainly as a result of the contraction in construction. According the expenditure approach, both consumption and investment expenditure supported growth. The total size of the Sri Lankan economy was estimated at USD 88.9 billion, while the per-capita GDP was recorded at US dollars 4,102 in 2018, which was marginally lower than in the previous year.

The external sector of the economy was volatile during the year due to both global and domestic factors. Globally, monetary policy normalization, particularly in the United States of America (USA), resulted in global financial conditions tightening, thus causing capital outflows from emerging market economies and increased pressure on exchange rates of twin deficit economies, in particular. In 2018, total export recorded USD 11.89 billion while the imports of the country increased USD 22.23 billion by representing the highest trade deficit in the history of Sri Lanka. Although services exports are estimated to have grown substantially, the deficit in the merchandise trade balance, stagnant workers' remittances and rising foreign interest payments resulted in a widened current account deficit of 3.2% of GDP during the year.

In terms of fiscal operations during 2018, Sri Lanka acquired some improvements with a higher primary surplus and a lower budget deficit, notwithstanding the decline in revenue mobilization. According to the annual report. the government revenue dropped to 13.3% of GDP in 2018 while expenditure and net lending declined, particularly due to lower public investment, which was affected by political tensions

that prevailed towards the end of the year resulting in delays in the implementation of budgetary operations.

The primary balance, which mirrors the difference between the government revenue and non-interest expenditure, registered a surplus of 0.6% of GDP in 2018 compared to the surplus of 0.02% of GDP in 2017. The budget deficit declined to 5.3% of GDP in 2018 from 5.5% of GDP in 2017 as a result of the substantial reduction in capital expenditure, but a deviation from the target level of 4.8% of GDP envisaged in the Budget 2018 was also observed.

Further, 2018 annual report declares, even though the government has made efforts to maintain the country's macroeconomic stability over the past several years, because of the postponement of much needed structural reforms has led the Sri Lankan economy to a modest growth path. Sri Lanka's graduation to the middle income status almost a decade ago required far reaching policy reforms to move towards higher income status by avoiding the so-called middle income trap.

However, lack of introducing growth enhancing reforms in the areas of export promotion, attracting FDI, reducing budget deficits and debt levels, reforming factor markets, strengthening public administration, and ensuring the rule of law have largely

contributed Sri Lanka's economic to stagnation, while peer economies have progressed rapidly as a result of growth supporting reforms. Therefore, for Sri Lanka to succeed as a higher income economy and improve the wellbeing of its people, it is essential that the root causes for the continued low economic growth by expediting the required addressed structural reforms with a focus on improving productivity and efficiency of the economy. In this background, it is vital that all stakeholders make concerted efforts to expedite the reform agenda that is already in place, which includes the National Export Strategy (NES) and New Trade Policy (NTP) to improve earnings from merchandise and service exports, the fiscal consolidation programme to improve fiscal discipline and debt sustainability, and the Central Bank's move towards adopting FIT by 2020 to ensure price stability. sustained The implementation of these reforms will not only improve Sri Lanka's economic outlook and its prospects as a highly sought-after destination for investments given the country's strategic location in the Indian Ocean, but also would be essential to uplift the overall standard of living and quality of life of its people.






#### **Composition of Exports - 2018**




#### Composition of Imports - 2018




#### **Exports under EU GSP/GSP+ Scheme**




#### Exports, Imports and Trade Deficit (US\$ billion)

## From Waste to Wearable: The Journey of the New Sri Lanka Cricket Jersey

MAS Holdings, through its groundbreaking sustainability initiative 'Ocean Plastics', implemented in partnership with the Sri Lanka Navy, Eco Spindles and Sri Lanka Cricket, has successfully upcycled waste plastic recovered from the beaches of Sri Lanka, to produce the official jerseys to be worn by Sri Lanka's national cricket team during the ICC Cricket World Cup 2019. Through this alliance, MAS is contributing towards establishing a long-term solution for the pressing marine pollution issue, which threatens the coastal belt of Sri Lanka.

With one-third of the island nation's population residing along its extensive 1,340 km coastline, Sri Lanka makes a impact disproportionate to marine pollution. In 2015 as part of the company's sustainability mandate, MAS commenced an open dialogue with the Sri Lanka Navy, who were already clearing up to 800kg of coastal waste each week through an especially established Marine Conservation and Monitoring Unit (MCMU). This led to the signing of a Memorandum of Understanding (MoU) between MAS and the Sri Lanka Navy to upgrade the existing project to a comprehensive waste collection and segregation initiative in 2016. As part of its initial involvement, MAS donated three plastic crusher machines to the Sri Lanka Navy, for installation at selected waste collection sites.

"Ocean Plastics is a project that will positively impact our coastline, marine life, and our coastal communities. The navy has a unique perspective on the impacts of plastic, and we see the potential that this project and other public-private partnerships have to preserve our nation for future generations," Navy Commander Piyal de Silva added.



The MAS – Sri Lanka Navy partnership was followed by one of the largest coastal cleanups across the island, with 1,500 volunteers from MAS and the Sri Lanka Navy collecting 9 tonnes of trash from 25km of coastline along 13 Sri Lankan beaches in just one weekend, setting a precedence for other corporates and volunteers to follow. Eco Spindles (formerly Beira Enviro Solutions), a subsidiary of The Beira Group and long-term recycling partner of MAS Holdings was then introduced to add value to this partnership, by salvaging and recycling PET (Polyethylene Terephthalate) plastics.

During this rapid progress of the Ocean Plastics project, MAS was also aligning its overall operations, practices and partnerships with the UN's Sustainable Development Goals (SDGs). This resulted in MAS recalibrating the drive for innovation to better integrate with its sustainability initiatives, and one such innovation-driven collaboration came from MAS' partnership with Sri Lanka Cricket (SLC).

The MAS – SLC partnership of over ten years, focused heavily on elevating performance characteristics of apparel to support the national cricket team in optimizing their onfield execution of the game. The Ocean Plastics project afforded MAS a different perspective of sustainably advancing both process and product with already mastered technologies

Such as moisture management, and 4 years of deep research into waste management. Eco Spindles began recycling PET plastics into polyester yarn that MAS Holdings then used in its perfected manufacturing process of performance apparel. This culminated in producing breakthrough fabric used to produce the Sri Lanka national cricket team jerseys for the ICC Cricket World Cup 2019.

Sea turtles are an important part of Sri Lanka's coastal ecosystem, with our shores providing abundant nesting for 5 of the 7 existing species of sea turtles in the world. Jellyfish and seaweed make up a large share of their diet, so it came as no surprise that sea turtles were falling victim to Sri Lanka's marine pollution, vulnerable to waste at all stages of life from eggs to hatchlings, and from juvenile turtles to adults. The Ocean's Plastic project will contribute to reducing the pollution caused by waste plastic in our coastal waters and to mark this, a design element of the jersey represents sea turtles.

It is MAS' hope, that the Sri Lankan cricket jersey will create awareness among both locals as well as foreign tourists who visit Sri Lanka annually to witness the turtle nesting season, driving a message of conservation along with sustainable waste management through the Ocean Plastics initiative. The front of the cricket jersey displays an abstract

abstract sea turtle design that depicts the yarn spun from recycled plastics, with a blue and yellow colour combination illustrating golden sunrays striking the sea. The design element on the back of the jersey has been aesthetically inspired by the turtle shell.

"Through our groundbreaking waste-to-wearable sustainability initiative, we have been able to manufacture a revolutionary performance fabric that promises to be a two-fold solution; first as part of MAS' progressive innovation mandate, and next as part of a high-impact eco-friendly sustainability initiative. We expect to drive this innovation forward, and are excited at the prospect of reaping greater results as our product and process evolves," concluded Rashmika Peiris, Business Director at MAS Active.

A significant milestone in MAS' sustainable journey, the success and potential of the Ocean Plastics initiative highlights the conglomerate's long-term investments in sustainable manufacturing over the past three decades of operation.




