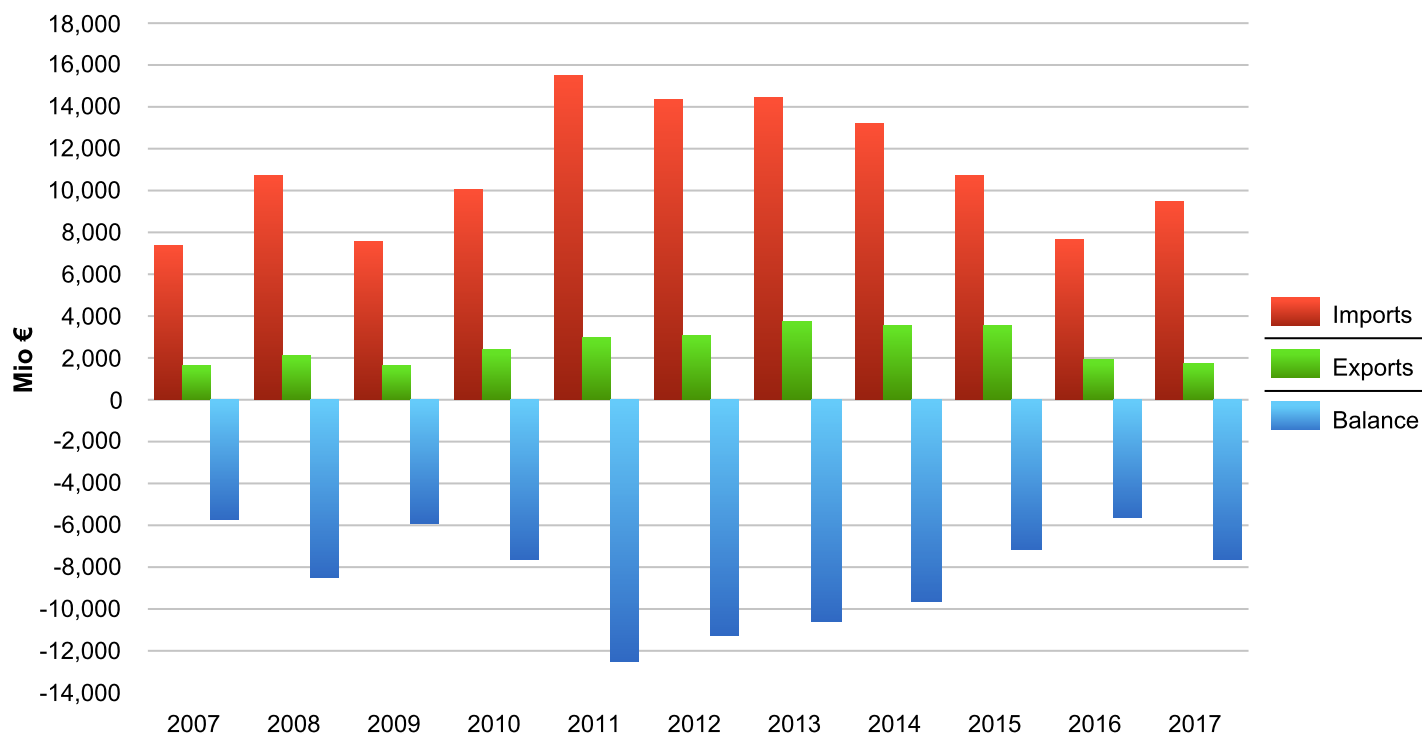

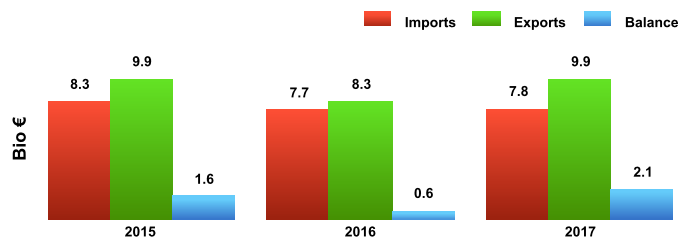

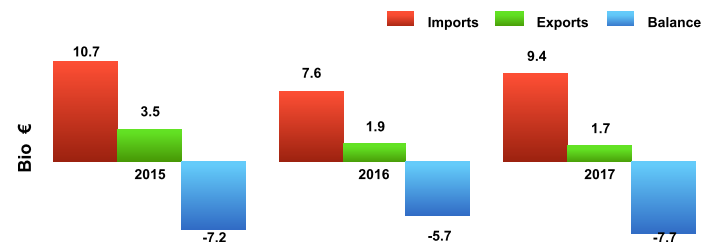

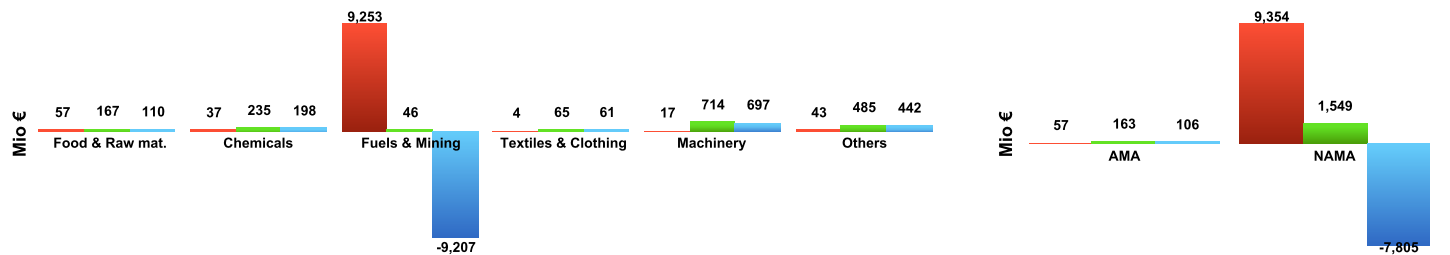

EU Merchandise trade with Azerbaijan by product (2017) - SITC (UN) & AMA/NAMA (WTO)

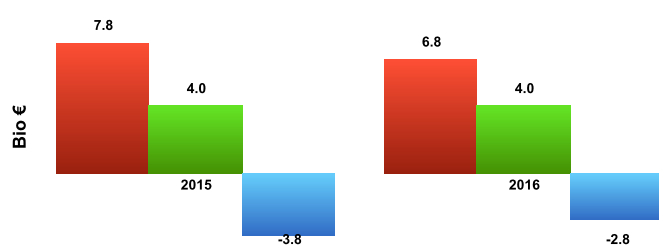

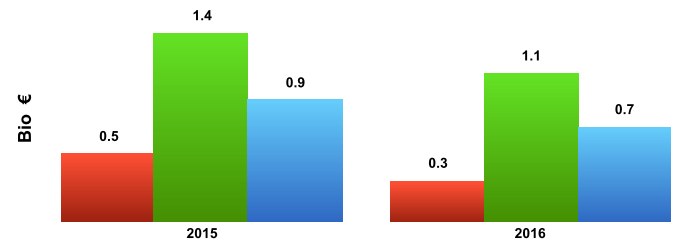

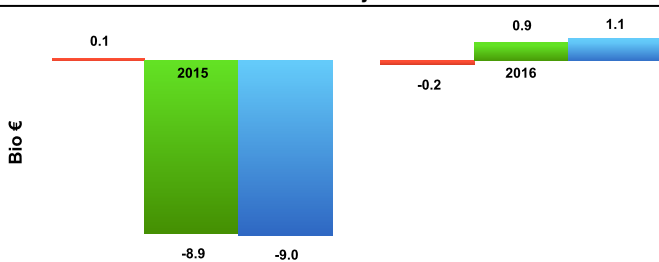

Foreign Direct Investment

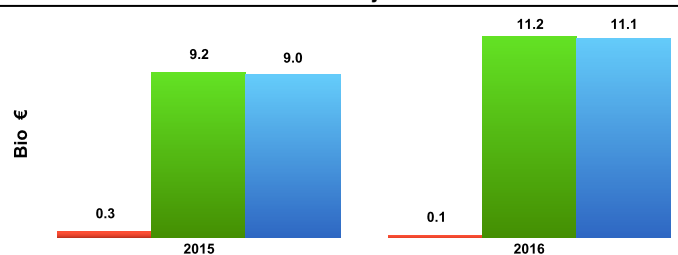
EU FDI Flows with Azerbaijan
