Dear Ladies and Gentlemen,

The system of German dual vocational training combines in-company training in the workplace with education in vocational schools or training centers, which prepares trainees for the successful transition to working life. The hands-on training of skilled workers is a unique feature of German dual vocational training. AHK Sri Lanka offers various vocational training services, such as consultation and organization of dual vocational training courses, examinations, Train-the-Trainer courses (AdA), and certification according to German quality standards.

Accredited by AHK Sri Lanka, the DIMO Academy for Technical Skills (DATS) is the only dual vocational training partner to offer category A certified VET courses in Sri Lanka. DATS will continue to offer trainings in the fields of automobile mechatronic technicians and Plant Engineering for Sanitary Heating and Air Conditioning (PESHA). The graduation of the first batch of automobile mechatronics concluded successfully in March 2022 and subsequent batches are ongoing.

AHK Sri Lanka, GIZ VTSL, and the partner companies are cooperating to develop and implement a comprehensive and practice oriented cooperative training for warehouse operators. A pilot course is being conducted with logistic-sector front runners Aitken Spence, Hayleys, John Keells, EFL Global, and Hellmann MAS. The second phase of the project commenced on 25th April 2022 with Aitken Spence and Abans Logistics.

Together with GIZ VTSL and J.M. Wickramarachchi & Co. (PVT) Ltd, AHK Sri Lanka is providing a comprehensive and practice-oriented training course on ophthalmic technicians (NVQ Level 3) and optometrists (NVQ Level 5).

The graduation ceremony of the "Technipreneurs" program will be held on 05 May 2022 with graduates comprising welding technicians and electrical technicians. The project focuses on enhancing the professionalism and entrepreneurship of Sri Lankan craftsmen.

Lastly, AHK Sri Lanka in cooperation with GIZ VTSL and Edwin Lemke — Training by Understanding will commence a Train the Trainer online course "Ada International Basic" in May 2022. HR managers and in company trainers are encouraged to apply.

COVID-19 Update

As of 03 May 2022, Sri Lanka accounted for 774 active COVID-19 cases, while recovered individuals totaled 646,129 and fatalities related to COVID-19 amount to 16,505 individuals.

Ceylon GI Cinnamon receives Certification from the European Union On 27 April 2022, the European Union (EU) handed over the Geographical Indication (GI) certification to Ceylon Cinnamon, Sri Lanka's first GI-certified product. The GI application was organized Sri Lanka **Export** bγ **Board** Development (EDB) and supported by the EU under the EU-Sri Lanka Trade Related Assistance Project and through technical assistance from UNIDO and the International Trade Centre (ITC). The joint support from private and public stakeholders has been instrumental in achieving Sri Lanka's first GI certification.

Sri Lanka is the world's largest producer and exporter of cinnamon accounting for 90% of the global market share. Although there are many varieties of cinnamon, Ceylon Cinnamon is pure and considered superior due to its delicate

taste and properties that contribute to many health benefits.

Import Regulations

Imports and Exports Control Regulation No 06 of 2022 was published on 09 April 2022; imposing the requirement for an Import Control License (ICL) to import selected items.

According to the regulations, among others, items such as food and beverages (under HS headings 03.04, 04.02, 04.03, 04.05, 04.06, 08.05, 08.06, 08.08, 08.10, 11.04, 11.05, 11.07, 11.08, 18.06, 19.02, 19.04, 20.09, 22.02, 22.03, 22.04, 22.05, and 22.08) consumer goods, including shampoo, makeup and detergents (under HS headings 33.03, 33.04, 33.05, 33.06, 33.07, and 34.01), apparel and rubber products (under HS headings 40.11, 40.12, 40.16, 42.01, 42.02, 42.03, 42.05, 61.17, 62.15, 62.17, 63.03, 63.04, 63.05, and 43.04), construction and furniture (under HS headings 44.21, 57.02, 57.03, 57.05, 69.12, 70.13, 73.21, 73.23, 73.24, 76.15, 82.15, 83.05, 83.06, 94.03, and 94.05,) electrical/electronic items (under HS headings 84.14, 84.15, 84.18, 84.50, 85.08, 85.09, 85.10, 85.13, 85.16, 85.17, 85.25, 85.27, 85.28, 85.29, 85.39) require a

valid import control license issued by the Controller General of Imports and Exports Control prior to importation.

Fitch Downgrades Sri Lanka to 'C'

Fitch Ratings has downgraded Sri Lanka's Long-Term Foreign-Currency Issuer Default Rating (IDR) to 'C' from 'CC'.

The downgrade of Sri Lanka's Long-Term Foreign-Currency IDR reflects Fitch's view that a sovereign default process has begun. This reflects the announcement by the Ministry of Finance on 12 April 2022 that it has suspended normal debt servicing of several categories of its external debts, including bonds issued in the international capital markets and foreign currency-denominated loan agreements.

CBSL Annual Report 2021

The 2021 Annual Report of the Central Bank of Sri Lanka was released on 29 April 2022 and can be referred here.



GDP Growth

Statistics by DCS

According to the 2021 GDP statistics published by the Department of Census and Statistics in Sri Lanka, the GDP growth in 2021 indicated a growth rate of 3.7%. In quarter 4 2021, GDP growth amounted to 1.8%. Agriculture, Industry, Services contributed to the GDP by 9%, 27.8%, and 57.5% respectively.

Forecast by the IMF

According to the International Monetary Fund (IMF), Sri Lankas' GDP real GDP forecast is expected to be 2.6% in 2022, compared to the previous forecast of 3.3%.

Estimate by World Bank According to the recently published estimates by the World Bank, GDP growth in Sri Lanka is estimated to be 0.3% in 2022.

Forecast by Asian Development Bank

As per the GDP forecast by ADB, Sri Lanka's economic growth will dip to 2.4% in 2022 and improve marginally to 2.5% in 2023.

Inflation

Headline inflation as measured by the National Consumer Price Index increased from 17.5% in February 2022 to 21.50% in March 2022.

March Inflation based on the Colombo Consumer Price Index increased from 15.1% in February 2022 to 18.70%.

Foreign Currency Reserves and Exchange Rates

As of 31 March 2022, the Official Reserve Assets in Sri Lanka amounted to USD 1,917 Mn, and the Foreign Currency Reserves amounted to USD 1,702 Mn.


From the beginning of the year up to 29 April 2022, the Sri Lankan rupee depreciated against the US dollar by 41.4%. The Sri Lankan rupee depreciated against the Euro by 36.9% and depreciated against the pound sterling by 36.5% during the same period.

Foreign Trade

Export Sector

According to the statistics published by the Export Development Board, Sri Lanka's merchandise exports in February 2022 amounted to USD 1,046 Mn, indicating y-o-y growth of 9.91%.

Merchandise Earnings in January 2022 amounted to USD 1,101 Mn, which is an increase of 17.5% compared to the previous year. The export volume index increased by 20.1% and the unit value index increased by 2.2% in January 2022.



German Exports to Sri Lanka

German exports to Sri Lanka in Jan-Feb 2022 decreased by 11.6% to EURO 37 000,000 compared to EURO 32 701,000 during the previous year.

German Imports from Sri Lanka

Germany imported from Sri Lanka goods amounting to EURO 126 503,000 in Jan-Feb 2022, compared to EURO 152 691,000 in the same period of the previous year, indicating an increase of +20.7%.

Sri Lankan Global Exports

Tea Industry

Export earnings from tea decreased by -10.04 % to USD 192.09 Mn in February 2022, compared with the same period of 2021. All export categories of tea, including tea packets (8.6%), bulk tea (11.44%), instant tea (20.7%) and green tea (24.66%) declined in the said period.

Rubber and rubber-finished products Industry

Export earnings from Rubber & Rubber finished products increased by 7.41 % y-o-y to USD 180.28 million in February 2022. Export of pneumatic & retreated rubber tyres and tubes (12.55%) was the highest contributor from exports in the rubber industry.

Coconut and coconut-based products Industry

In February 2022, export earnings from the coconut industry amounted to USD 136.20 Mn, indicating a growth of 18.87% compared to the previous year.

Apparel Industry

Export earnings from Apparel & Textiles increased to USD 1,009.23 Mn in February 2022, indicating y-o-y growth of 16.96%. Export of apparel and woven fabrics expanded by 17.88% and 40.9% while exports of made-up textile articles, yarn and other textile articles were down by 14.87% and 9.63%.


Spice Industry

Export earnings from spices in February 2022 amounted to USD 62.12 Mn, a decrease of 17.82% compared to the corresponding period of the previous year.

Sri Lankan Global Imports

Merchandise imports for the period January 2022 amounted to USD 1,959 Mn, indicating a growth of 23.1% y-o-y.

In January 2022, import volume increased by 2.3% and the unit value indices increased by 20.3% y-o-y.




Vehicle Imports

Personal vehicles imported in January 2022 amounted to USD 0.7 Mn, indicating a y-o-y increase of 31.9%.

Manufacturing Sector Purchasing Managers' Index (PMI)


The manufacturing sector PMI in March 2022 amounted to 57.8, which is an increase of 5.3 index points compared to the previous month.

Services Sector Purchasing Managers' Index (PMI)

The Services sector PMI amounted to 51.3 in March 2022, which is a decrease of 0.5 index points compared to February 2022.



Tourism Sector

In March 2022, 106,500 tourist arrivals were recorded in Sri Lanka, indicating a growth of 10.4% from February. During the same period, German tourists were among the top 3 tourist arrivals by country.

This relates to the standards governing the training system and content, with only marginal adjustment to local conditions.

- Submission of Health Declaration Form is NOT required.
- Quarantine is **NOT** required for passengers who are fully vaccinated or arriving with a negative COVID-19 test.

Unvaccinated/partially vaccinated travellers aged 12 years and above should carry:

• a negative COVID-19 PCR test report done within 72 hours.

Or

• a Rapid Antigen Test (RAT) report which was done within 48 hours from the departure time into Sri Lanka (self-swabs are not allowed).

Such passengers will be exempted from on-arrival testing.





Thailand Pass for travellers entering Thailand

Registration will be opened on Thailand Pass for travellers entering Thailand from 1st May 2022 under the new entry measures. COVID-19 test, both prior to and after arriving in Thailand, is no longer required for vaccinated passengers.

Travellers who have been already issued with a QR code from Thailand, do not need to register for a new pass.




