3. Purposes and legal basis of the data

4. Transfer of personal data to a third country

It is not planned to transfer your personal data to a third country or an international organization.

5. Duration of storage of personal data

6. Rights of persons affected

- Since data processing is based on a contractual basis and data processing is carried out using automated procedures, you may be entitled to data portability (Article 20 GDPR).
