


Economic survey

- Survey on economic and investment conditions in Croatia
- Conducted jointly with Chambers of Commerce and Industry (AHK) in 15 other countries across C&E Europe
- Provides reliable information on these markets by asking managers of companies
 - 150 companies surveyed



Surveyed companies' areas of operation






Key Findings

- Another decline of willingness to re-invest in Croatia
 - Most businesses still satisfied or optimistic
- Croatia still perceived as fairly attractive for investment among competing countries
 - Biggest detriments still corruption, tax system and public administration


Current economic situation in Croatia

Outlook for Croatian economy vs. previous year






Economic vs. own business situation






How will the business situation of your company develop compared to previous year (%)






Would you again choose Croatia as preferred location for your investment?






Potential threats to own business in 2019






How does the shortage of skilled workers affect your company?


Digitalisation Survey

- Survey on digitalisation status of Croatian companies
 - Conducted by GCCIC for the first time
 - 90 companies participated
- 60% of them are domestic companies and 40% part of an international group






Company size by revenues





Surveyed companies' areas of operation






Key Findings

- Half of surveyed companies already very or fully digitalised
- 3/4 of companies expect significant changes due to digitalisation in the following years
- Over 80% have a positive attitude towards digitalisation, 1/3 positive but lack knowledge
 - Top added values efficiency, planning & control, top risks qualification of employees & high investments

Top 5 added values	Top 5 obstacles and risks
1. Increase efficiency	1. Qualification and competences of employees
2. Better planning and control	2. High investments
3. Analysis and use of data	3. IT security
4. Increase in productivity	4. Lack of standardization and certifications
5. Cost reduction	5. Unclear economics benefits




Please rate the current level of digitalisation in your company






Which sentence describes your company's relationship to digitalisation?






To what extent has your business been impacted by the digital development?




Do you expect your business to change significantly in the next 3-5 years due to the digital development?





What are your planned investments in digitalisation in the next 5 years (share of turnover)?






