### **4. Purpose and legal basis of data processing**

The AHK Azerbaijan will store and use your personal data (contact details) for the administration of the member database, invitations to events and invitations to participate in surveys, invoicing and sending newsletters and information about the economic development in Germany and Azerbaijan as well as about the activities of the AHK Azerbaijan. The AHK Azerbaijan publishes your contact details exclusively in the online member portal and member directory (digital and print). In the online member portal, only AHK members have free access to these contact details.

Your data is processed pursuant to Article 6 (1) a) GDPR in conjunction with our charter.

The same purposes and legal bases apply to the processing of personal data of honorary members of the AHK Azerbaijan as apply to member companies.

### **5. Recipient or categories of personal data recipients**

We may pass on your personal data to third parties if this is necessary for the fulfilment of our contracts or legal obligations.

Your personal data will be transmitted to:

- Third party companies or other legal entities which are exercising their activities for the data controller as contract processors.
- The German Embassy Baku for inviting the events and for sending the information of the German Embassy Baku.

## **6. Transmission of personal data to the third parties**

It is not intended to transfer your personal data to a third party or to an international organisation.

The provision of your personal data is carried out by means of an online web application. Therefore confidentiality, integrity (inviolability), authenticity (genuineness) and availability of personal data cannot be guaranteed.

## **7. Duration of storage of personal data**

Your data is stored after the collection for the duration of your membership. Legal storage periods can make a retention necessary beyond that.

## **8. Rights of the data subject**

According to the EU General Data Protection Regulation, you have the following rights:

If your personal data is processed, you have the right to obtain information regarding with your stored personal data (Article 15 GDPR).

If incorrect personal data is processed, you have the right for correction (Article 16 GDPR).

If legal requirements are met, you have the right to request the deletion or limitation of processing, and you have the right to object to such processing (Articles 17, 18 and 21 GDPR).

In case of an objection, we will no longer contact you as a member, and the membership relations would end.

Since the data processing is based on a contractual basis and data processing is carried out via automated processes, you have a right to data portability where applicable (Article 20 GDPR).

Should you exercise your above mentioned rights, the AHK will review whether statutory requirements are met.
